# Safeguarding OLGC Children

- Tammy Beaven, Child Protection Liaison
  - Who Needs to be Background Check Compliant?
    - Adult volunteers (defined as 18 years old or older) having "substantial contact with children"
    - ALL paid employees (regardless of their level of contact with children)
  - Examples:
    - CCF (Catholic Christian Formation) Catechists
    - Children's Liturgy of the Word Volunteers
    - Coaching/Assistant Coaching
    - OLGC School Volunteers
    - Scout leaders
    - Volunteer Tutors
    - Youth Ministry Volunteers
    - All Employees/Consultants/Music Directors/Cantors
    - General Volunteers who work with children/teens

# Safeguarding OLGC Children

- **Process:**

1. Complete our online *Request a Background Check Packet* form
2. Complete the forms in the background check packet
  - a. Code of Conduct (Revised 10/04/12)
  - b. E/V Criminal Background History Check Authorization Form
  - c. VA Dept./Social Services/Central Registry Release of Info. Form (new code U00131)
  - d. Questionnaire (6 pages)
  - e. Acknowledgment of Receipt (23 pages) - sign and submit only page 23
  - f. Attend one (4-hour) VIRTUS Training (Protecting God's Children Program) (within 45 days from the date the paperwork begins being processed)
  - g. View the online training, Recognizing and Reporting Child Abuse, every 3-years (to start Spring of 2019)
